The CO-OP MOVING FORWARD TOGETHER Cooperative logo is the sole and exclusive registered intellectual property of Ministry of Industrial Development, SMEs and Cooperatives (Cooperatives Division). The Logo may be used only by enterprises subject to MINISTRY OF INDUSTRIAL DEVELOPMENT, SMEs AND COOPERATIVES (COOPERATIVES DIVISION)'s granting a non-exclusive licence and, if only if such use is made pursuant to the terms and conditions of the licence. Any failure by a user to comply with the terms and conditions contained in the licence may result in the immediate revocation of this licence, in addition to any other sanctions imposed by MINISTRY OF INDUSTRIAL DEVELOPMENT, SMEs AND COOPERATIVES (COOPERATIVES (COOPERATIVES)).

General Conditions for use of the logo

- 1. MINISTRY OF INDUSTRIAL DEVELOPMENT, SMEs AND COOPERATIVES (COOPERATIVES DIVISION) will allow registered Co-operative Societies (User) to use the CO-OP MOVING FORWARD TOGETHER logo only for products manufactured locally with a predetermined percentage of value addition as may be agreed by MINISTRY OF INDUSTRIAL DEVELOPMENT, SMEs AND COOPERATIVES (COOPERATIVES DIVISION).
- 2. The CO-OP MOVING FORWARD TOGETHER logo may be used in a professional manner on the User's Web site, stationery, literature, advertisements, storefront window, or in any other comparable manner to signify that the User is manufacturing the displayed products locally. The CO-OP MOVING FORWARD TOGETHER logo may not be used in any manner that discredits or tarnishes its reputation and goodwill; is false or misleading; violates the rights of others, any law, regulation, or other public policy; or mischaracterizes the relationship between MINISTRY OF INDUSTRIAL DEVELOPMENT, SMEs AND COOPERATIVES (COOPERATIVES DIVISION) and the user, including but not limited to any use of the CO-OP MOVING FORWARD TOGETHER logo that might be interpreted as an endorsement, approval, sponsorship, or certification by MINISTRY OF INDUSTRIAL DEVELOPMENT, SMEs AND COOPERATIVES (COOPERATIVES DIVISION) of the User, the User's business or organisation, or the User's products or services, or that might be interpreted as support or encouragement to purchase or utilise the User's products or services. User will clearly and prominently identify itself in its offers, advertising, marketing, and promotional materials.
- 3. The CO-OP MOVING FORWARD TOGETHER logo may only be used in the manner and for the purposes specified in the application form submitted to MINISTRY OF INDUSTRIAL DEVELOPMENT, SMEs AND COOPERATIVES (COOPERATIVES DIVISION) and as limited by any specific conditions.
- 4. MINISTRY OF INDUSTRIAL DEVELOPMENT, SMEs AND COOPERATIVES (COOPERATIVES DIVISION) may impose specific restrictions, conditions or limitations on the use of the logo (specific conditions), which will be notified to the user. Where and to the extent that the specific conditions conflict with these Conditions, the specific conditions shall apply.

- 5. MINISTRY OF INDUSTRIAL DEVELOPMENT, SMEs AND COOPERATIVES (COOPERATIVES DIVISION) may modify or amend any of the Conditions attached to the licence, even during the validity period of the licence and the licensee shall comply with the conditions. Any amendment or modification shall be in writing.
- 6. The licence is personal to the User and shall not be assigned or sub-licenced.
- 7. User may not use a logo obtained from any source other than MINISTRY OF INDUSTRIAL DEVELOPMENT, SMEs AND COOPERATIVES (COOPERATIVES DIVISION), and shall not modify or alter the logo in any way.
- 8. The User shall not use the Logo in connection with any activity that is unlawful, libellous, defamatory, obscene, or that in any way infringes the intellectual property or other rights of any person or entity.
- 9. Use of the CO-OP MOVING FORWARD TOGETHER logo shall create no rights for Users to use the logo beyond the terms and conditions of this limited and revocable licence. MINISTRY OF INDUSTRIAL DEVELOPMENT, SMEs AND COOPERATIVES (COOPERATIVES DIVISION) reserves the right to request samples of products in order to determine compliance with these terms and conditions. Without further notice, MINISTRY OF INDUSTRIAL DEVELOPMENT, SMEs AND COOPERATIVES (COOPERATIVES DIVISION) reserves the right to prohibit use of the CO-OP MOVING FORWARD TOGETHER logo if it determines that a User's logo usage, whether wilful or negligent, is not in strict accordance with the terms and conditions of this licence, otherwise could discredit MINISTRY OF INDUSTRIAL DEVELOPMENT, SMEs AND COOPERATIVES (COOPERATIVES DIVISION) or tarnish its reputation and goodwill. MINISTRY OF INDUSTRIAL DEVELOPMENT, SMEs AND COOPERATIVES (COOPERATIVES DIVISION) may revoke this licence for any reason it sees fit upon written notification to the User.
- 10. Permission shall be granted for a period such as may have been notified by MINISTRY OF INDUSTRIAL DEVELOPMENT, SMEs AND COOPERATIVES (COOPERATIVES DIVISION) as a specific condition, unless terminated earlier in accordance with paragraph 11 below:
- 11. Termination of use of CO-OP MOVING FORWARD TOGETHER logo by MINISTRY OF INDUSTRIAL DEVELOPMENT, SMEs AND COOPERATIVES (COOPERATIVES DIVISION):
 - a. MINISTRY OF INDUSTRIAL DEVELOPMENT, SMEs AND COOPERATIVES (COOPERATIVES DIVISION) may terminate this permission at any time by notice in writing sent by e-mail or post to the address given in the application form or such other address as the User has notified to MINISTRY OF INDUSTRIAL DEVELOPMENT, SMEs AND COOPERATIVES (COOPERATIVES DIVISION).
 - b. Where the permission is terminated as a result of the User's breach of these Conditions or any specific conditions, or as a result of the User ceasing to be a beneficiary or other approved body, it shall take effect immediately and the logo shall be removed from any website and stocks of materials bearing the logo shall immediately be withdrawn from distribution, at the expense of the User. By agreeing to these Conditions the User acknowledges that this is reasonable in order to safeguard MINISTRY OF INDUSTRIAL DEVELOPMENT, SMEs AND COOPERATIVES (COOPERATIVES DIVISION) rights in the logo.

- c. Where the permission is terminated for any other reason, MINISTRY OF INDUSTRIAL DEVELOPMENT, SMEs AND COOPERATIVES (COOPERATIVES DIVISION) shall give the User a period of three calendar months' notice at the end of which the User shall cease all use of the logo.
- 12. Use of the CO-OP MOVING FORWARD TOGETHER logo indicates the consent of the applicant/licensee to the interpretation of this agreement by Mauritian law, as well as his consent to jurisdiction and venue in the courts located in Mauritius. All actions regarding the CO-OP MOVING FORWARD TOGETHER logo shall be brought and maintained in the courts located in Mauritius, and you hereby waive all objections to jurisdiction, applicable law and venue therein.
