# ACHIEVEMENTS FOR THE PERIOD 01 JULY 2021 TO 30 JUNE 2022

#### 1. ACCESS TO FINANCE

## 1.1 BOOST TO LOCAL PRODUCTION SCHEME FOR COOPERATIVE SOCIETIES

The Boost to Local Production Scheme for Cooperative Societies is operational since July 2020. The Scheme finances 90% of the cost of the following up to a maximum of Rs150,000/per cooperative society related to local production of agricultural produce and food items:

- (a) Purchase of livestock; and
- (b) Acquisition of equipment, machineries and other related accessories.

A provision Rs 5milion was made for Financial Year (FY) 2021/2022. Thirty-three (33) cooperative societies have benefited from the scheme to the tune of Rs 4.83 million.

# 1.2 ASSISTANCE TO COOPERATIVES UNDER THE COOPERATIVE DEVELOPMENT FUND'S SCHEMES

The Cooperative Development Fund is operating several financial schemes with a view to assisting in the development of cooperatives. In FY 2021/2022, a sum of Rs 292,063/- has been disbursed under the following schemes to seventeen (17) cooperative societies:

# 1.3 GARMENT MAKING/TAILORING PROJECT

The Garment Making/Tailoring Project is one of the new sectors in which the Ministry is encouraging cooperatives to venture into with a view to encouraging more production at local level, thus saving on foreign currency, and also to making services available to the population in their proximity.

The Garment Making/Tailoring Project has two main components as hereunder:

- (a) Training in garment making/tailoring by the National Cooperative College (NCC) with the collaboration of the Fashion and Design Institute (FDI); and
- (b) A maximum financial assistance of Rs200,000 per cooperative for the following:
- ➤ 90% of the costs of equipment for garment making/tailoring shop up to a maximum of Rs150.000
- Six months' rental costs of the garment making/tailoring shop up to a maximum of Rs6,000/month (Rs 6,000x6 months)

# Signage and advertising materials to a maximum of Rs14,000

The first component has been completed and for the second component applications were received from six cooperative societies. For the period under review, disbursement was made to three cooperative societies as hereunder:

#### 2. ACCESS TO MARKET TO COOPERATIVES

# 2.1 COOPERATIVE FAIRS

Cooperative Market Fairs are held to provide a platform to cooperative societies to market their local products, establish business networks, and also increase the visibility of the goods and services of the cooperative societies.

### 3. GREEN PROJECTS

#### 3.1 SOLAR PHOTOVOLTAIC REBATE SCHEME FOR COOPERATIVES

The Ministry operated a Solar Photovoltaic Rebate Scheme for Cooperatives. Under the Scheme, Cooperatives have benefited from roof-mounted grid tie PV kits of 2 kilowatt peak (kWp) capacity. Cooperative societies did not incur any investment cost. The CEB procured, owned and had the responsibility for operation and maintenance of the PV kits.

An official launching of the Solar Photovoltaic system was made on 18 September 2021 at L'Escalier Cooperative Credit Society, which is one of the beneficiaries of the Solar Photovoltaic Rebate Scheme for Cooperatives. The official launching was made by Hon. Soomilduth Bholah, Minister of Industrial Development, SMEs and Cooperatives.

For Financial Year 2021/2022, 6 cooperative societies have benefited from the installation of solar photovoltaic kits which was part-financed by the SME Mauritius Ltd.

## 3.2 WORKSHOP ON RECYCLING FOR COOPERATIVES

With a view to promoting recycling activities among cooperatives, a one-day workshop on Recycling was organized by the Cooperatives Division of the Ministry in collaboration with the National Cooperative College, Bois Marchand, Terre Rouge. The workshop was attended by 32 cooperators.

#### 4. REGISTRATION OF COOPERATIVES

## 4.1 <u>NEW COOPERATIVES</u>

118 cooperative societies were registered during the period 01 July 2021 to 30 June 2022 out of which 40 cooperative societies have been registered as Multipurpose Cooperative Societies with a view to allowing the society to be engaged in various activities.

#### 5. EVENTS ON COOPERATIVES

#### 5.1 CELEBRATION OF THE INTERNATIONAL DAY OF CO-OPERATIVES 2021

The International Day of Co-operatives (IDC) is an annual celebration of the cooperative movement observed on the first Saturday of July. For year 2021, the International Day of Cooperatives was celebrated on the 3<sup>rd</sup> of July.

The theme of the International Day of Cooperatives 2021 is "REBUILD BETTER TOGETHER". The theme was chosen to support Sustainable Development Goal (SDG) 3 on Good Health and Wellbeing. Cooperatives were thus provided an opportunity to showcase how they are meeting the Covid-19 pandemic crisis with solidarity and resilience and offering communities a people-centered and environmentally-just recovery.

In Mauritius, to mark the International Day of Cooperatives 2021, the Ministry of Industrial Development, SMEs and Cooperatives (Cooperatives Division) had organized a gathering of co-operators at the National Cooperative College, Terre Rouge.

# 6. RE-ENGINEERING OF THE COOPERATIVES DIVISION

# 6.1 WORKSHOP ON "RE-ENGINEERING OF THE COOPERATIVES

The Cooperatives Division of the Ministry of Industrial Development, SMEs and Cooperatives organised a half-day workshop on the theme "*The Re-engineering of the Cooperatives: The Way Forward*" in October 2021 at the Labourdonnais Waterfront Hotel, Caudan Port-Louis. The workshop was attended by cooperators, officers of the Division as well as representatives of the Union for Technical Staff of the Cooperative Societies Section.

The main objectives of the workshop were *inter-alia* to:

- (i) Provide information on how the re-engineering will foster growth and modernisation of the cooperative sector while focusing on the promotion and development of new fields of activities;
- (ii) Sensitise cooperatives and officers of the Division on the re-engineering strategy and the mechanism for its implementation so as to ensure the smooth transition;
- (iii) Establish the sense of belonging from different stakeholders to the project; and
- (iv) Obtain the views/proposals/suggestions from the different stakeholders.

# 6.2 LAUNCHING OF COOPERATIVES BUSINESS CENTRES

The Ministry of Industrial Development, SMEs and Cooperatives (Cooperatives Division) solicited the assistance of the Office of the Public Sector Governance (OPSG) to carry out a restructuring exercise with a view to providing appropriate institutional set up to foster growth

and for the modernisation of the Cooperative Sector, while focusing on the promotion and development of new fields of activities.

Based on the recommendations of the OPSG Report, the Cooperatives Division prepared an Action Plan for the Re-engineering of the Cooperatives Division. One of the measures of the Action Plan is the re-organisation of the 12 Regional Cooperative Centres (RCCs) into five Cooperative Business Centres (CBCs). The RCCs have thus been re-organised into CBCs. An official launching of the CBCs was held in February 2022.

# 7. SENSITISATION ON COOPERATIVES

## 7.1 SENSITISATION ON COOPERATIVES

The Cooperatives Division carried out 56 sensitisation programmes around the island with a view to *inter-alia* disseminating information to the public on the cooperative business model, especially amongst others regarding setting up of cooperative societies and writing-up of business plan. The sensitisation programmes were attended by 820 participants. Details of the programmes are as follows:

Its certification is valid until 14 September 2023. The Cooperatives Division has aligned itself to the new standard and upgraded its quality system.

#### 11. EMPOWERING WOMEN COOPERATIVES

# 11.1WORKSHOP ON E-MARKETING FOR WOMEN COOPERATIVE SOCIETIES.

With a view to promoting e-marketing among women cooperative societies, a two-day Workshop on E-Marketing for Women cooperative societies was organised on 19 May 2022 by the Mauritius Women Entrepreneurs Cooperative Federation Ltd (MWECF) in collaboration with Cooperatives Division of the Ministry and the National Cooperative College

(NCC). The main objectives of the workshop were to enlarge the scope of business of women cooperators through digitalization; and increase the customer base of women cooperatives. The workshop was attended by 30 women cooperators.
